


Virtual Forum: 2020 Coastal Forum


Webinar: Assessing Resilience in U.S. Markets

Decarbonizing the Built Environment: 10 Principles for Climate Mitigation Policies

With leading cities refining their climate action plans and hundreds of more cities preparing to develop plans, the public and private sectors can unite around a set of principles to help accelerate progress toward these shared climate action goals. This recent report, prepared in partnership with USDN, serves as a starting point for cities interested in engaging real estate leaders during the shaping of climate mitigation policies, and for real estate organizations to increase their understanding of the potential impact of these policies—providing useful tools to help city officials and those in the real estate industry engage with each other in a meaningful and ongoing way. Each of the principles identified in this report is a distillation of recommendations identified during ULI's City and Real Estate Sustainability workshops, in which more than 60 public and private sector leaders participated. Rocky Mountain InstituteTenant Energy Optimization Program Case Study

Rocky Mountain Institute (RMI), an international nonprofit organization, had outgrown its office space and wanted to lease space in a hyperenergy-efficient and sustainable net-zero-energy (NZE) office building. As a result, RMI ended up as the anchor tenant in Boulder Commons, an all-electric, aspiring NZE property in Boulder, Colorado. At the time of its completion, Boulder Commons, developed by ULI Greenprint member Morgan Creek Ventures, was the largest leased multi-tenant aspiring NZE mixed-use commercial project in the United States. The NZE process for this project was cost-effective for both the developer and the tenants, and it can serve as a model for the next level of high-performing, sustainable tenant spaces.



Business Case for Resilience in Southeast Florida

ULI's Urban Resilience program hosted two virtual focus groups to gather industry input on key aspects of the <u>Business Case for Resilience in Southeast Florida project</u>. The Urban Resilience program is partnering with the SEFL District Council and AECOM, on behalf of the <u>Southeast Florida Climate Change Compact</u>, to proposes strategies for climate adaptation in the region and assess the business case for implementation of resilience infrastructure. The focus groups provided valuable feedback on how this research can be leveraged to inform decision making and help align region wide communications around resilience. A final report will be published summer 2020.
