<u>Rachael Dietkus</u> is a licensed clinical social worker, certified clinical trauma professional, and a design researcher and strategist dedicated to trauma-responsive practices in design. After a 10-year career working with social justice and human rights non-profits, Rachael earned her MSW in 2010 and then served in senior-level roles within the federal government and higher education in the United States. Rachael has also served as an <u>AmeriCorps</u> member with the Red Cross and as an NGO delegate to the United Nations Human Rights Council. She is currently a Governor-appointed statewide Commissioner with the <u>Serve Illinois Commission on</u> <u>Volunteerism and Community Service</u>.

Rachael's practice is right at the intersection of social work, design, and a deep understanding of trauma. She advocates for social workers in design and tech, studies and writes about the impacts of trauma in the context of design, and focuses on how and why trauma-responsive methods are needed in design research and practice. She is the Founder and Chief Compassion Officer of <u>Social</u> <u>Workers Who Design</u>. She speaks and works closely with design practitioners and design educators worldwide.

Roshanak Mehdipanah is an Assistant Professor in the Department of Health Behavior and Health Education in the School of Public Health. She specializes in innovative research methods including realist evaluations and concept mapping to develop conceptual frameworks linking complex interventions to health. Dr. Mehdipanah has led several projects on housing and health including health evaluations of housing policies on affordability and discrimination within the U.S.A. Prior to joining the faculty in HBHE, Dr. Mehdipanah was an investigator with the SOPHIE project (Evaluating the Impact of Structural Policies on Health Inequalities) funded by the European Union. Within this project, she led a four-year evaluation of an urban renewal policy and its effects on the health and health inequalities in some of Barcelona's neighborhoods. Dr. Mehdipanah's current research portfolio focuses on aspects of urban health including urban renewal, planning, housing and gentrification.



Kacey Cordes is a Vice President, Assistant Director of Project Management within the Affordable Housing team at U.S. Bancorp Community Development Corporation (USBCDC) headquartered in St. Louis, Missouri. Kacey has closed approximately \$300MM in low-income housing tax credit investments across the country. Lisa Y. Gordon is the Chief Operating Officer for the City of Atlanta. She joined the Dickens administration in February 2022. Gordon is the former President and Chief Executive Officer of Atlanta Habitat for Humanity where she led one of the highest producing and impactful affiliates in the country. As a result of her strategic action, she quadrupled the number of families served in four years with a goal to serve over 1,000 additional families in five years. She leveraged a \$74 Million balance sheet comprised of a construction business, retail store and mortgage company for exponential impact. Gordon is a strategic leader and consensus builder who enjoys working on complex business issues and creating opportunities for success. She is a financial expert and has a strong acumen for complex transactions, public-private partnerships, and extensive experience with audit committees and financial reviews.

She was the architect of the city of Atlanta's first five-year financial plan - a strategic document used to build the city's reserves and increase their bond rating to A+. She also led the organization out of a \$80 million dollar deficit that received accolades from the Mayor and City Council.

In recognition of her financial savvy and leadership skills she was appointed to the Global Governing Trustee Board and the Americas Executive Committee of the Urban Land Institute (ULI), the leading real estate organization serving 45,000 members globally. She was the first person of color to Chair the ULI Atlanta Board and is a nationally recognized policy expert and fellow of the prestigious National Academy of Public Administration. She also serves as expert adviser for national strategy initiatives commissioned by the U.S. Congress.
